Specific arrangements applying to this Agreement.

Passengers and unaccompanied baggage.

All passengers and their baggage shall be screened prior to entry to the port facility by the Ship Security Officer, ship security personnel or the Ship agent. Passengers and luggage shall be transported by vehicle and be escorted by ship security personnel through the facility to the ship gangway. The PFSO shall be notified of all passenger and baggage transfers.

Unaccompanied baggage will only be accepted through the facility if it has been screened prior to entry under the direction and control of the Ship Security Officer, ship security personnel or the Ship agent. Screened unaccompanied baggage will be escorted through the facility to or from ship side for immediate transfer under the direction and control of the Ship Security Officer, ship security personnel or the Ship's Agent.
